Last week's doctrinal topic was "Abortion" and has much in common with this week's topic – Euthanasia. By definition:

euthanasia

Also called mercy killing, it is the act of putting to death painlessly or allowing to die, as by withholding extreme medical measures, a person or animal suffering from an incurable, especially a painful, disease or condition – painless death.

Our doctrinal statement is as follows:

(T) <u>Euthanasia</u>. We believe that the direct taking of an innocent human life is a moral evil, regardless of the intention. Life is a gift of God and must be respected from conception until natural death. Thus we believe that an act or omission which, of itself or by intention, causes death in order to eliminate suffering constitutes a murder contrary to the will of God. Discontinuing medical procedures that are extraordinary or disproportionate to the expected outcome can be a legitimate refusal of over-zealous treatment. (Ex. 20:13, 23:7; Matt. 5:21; Acts 17:28)

 All doctrinal beliefs MUST begin with the Word of God = what does the Bible say?

Ex. 20:13 Thou shalt not kill.

Mt. 5:21 Ye have heard that it was said by them of old time, **Thou shalt not kill**; and whosoever shall kill shall be in danger of the judgment:

"Life is a gift of God and must be respected from conception until natural death."

<u>Gen. 1:26</u> And God said, Let us make man **in our image**, after our likeness: and let them have dominion over the fish of the sea, and over the fowl of the air, and over the cattle, and over all the earth, and over every creeping thing that creepeth upon the earth. <u>27</u> So God created man in his *own* image, in the image of God created he him; male and female created he them. <u>Gen. 2:7</u> And the LORD God formed man of the dust of the ground, and breathed into his nostrils the breath of life; and man became a living soul.

- To promote euthanasia, or abortion, one must hold no respect for an individual's life.
- To hold no respect for life, is to hold no respect for the Creator of life.

Job 33:4 The Spirit of God hath made me, and the breath of the Almighty hath given me life.

Jn. 6:33 For the bread of God is he which cometh down from heaven, and giveth life unto the world.

<u>Acts 17:25</u> Neither is worshipped with men's hands, as though he needed any thing, seeing **he giveth to all life, and breath, and all things**;

 To take a life of one created in the image of the Creator, is worthy of "capital punishment."

<u>Gen. 9:6</u> Whoso sheddeth man's blood, by man shall his blood be shed: for in the image of God made he man.

For a believer, to consider euthanasia is to forget to Whom you belong!

<u>1 Cor. 6:19</u> What? know ye not that your body is the temple of the Holy Ghost *which is* in you, which ye have of God, **and ye are not your own**?

<u>20</u> For ye are bought with a price: therefore glorify God in your body, and in your spirit, which are God's.

The taking of a life is considered by God to be "wicked."

Ex. 23:7 Keep thee far from a false matter; and the innocent and righteous slay thou not: for I will not justify the wicked.

<u>Mt. 15:19</u> For **out of the heart** proceed evil thoughts, **murders**, adulteries, fornications, thefts, false witness, blasphemies: "Discontinuing medical procedures that are extraordinary or disproportionate to the expected outcome can be a legitimate refusal of over-zealous treatment."

Special challenges regarding euthanasia

What about those on respirators who are brain dead?

Technically, they are dead and cannot "come back" to consciousness.

What about those who are in constant pain?

Modern pain killing medicines offer most dying patients relief. Avoidance of pain as a reason for mercy killing is an ineffective medical argument. As Christians, we believe God has a reason for everything under heaven, yes, even suffering.

Rom. 8:28 And we know that all things work together for good to them that love God, to them who are the called according to his purpose.

 God's will, even to suffer, must be accepted by faith for each individual.

Jn. 9:1 And as Jesus passed by, he saw a man which was blind from his birth.
2 And his disciples asked him, saying, Master, who did sin, this man, or his parents, that he was born blind?
3 Jesus answered, Neither hath this man sinned, nor his parents: but that the works of God should be made manifest in him.

What's the difference between hospice and palliative care?

A doctor writes an order for hospice care when the doctor believes that the patient only has six months or less to live.

The definition of palliative care is that of comfort measures for someone who is seriously ill but has a life expectancy of years instead of months. The goal during hospice care is to make the patient as emotionally, physically, and spiritually as comfortable as possible.

Doctors Starved Quadriplegic Coronavirus Patient to Death Because of His Disability

TEXAS RIGHT TO LIFE JUN 26, 2020 | 12:15PM AUSTIN, TX

Michael Hickson, a 46-year-old COVID-19 patient, was starved and left without adequate treatment for his illnesses at St. David's South Austin Medical Center. His wife, Melissa, says the hospital refused to treat his illnesses because of his disability.

Michael was conscious and alert but could not communicate verbally. He responded to jokes, shook his head, and puckered his lips on a FaceTime call when Melissa requested a kiss. Melissa asked if she could pray with her husband and their children, to which he nodded "yes." But the doctor soon told Melissa her husband would be placed in hospice against her will. In a recorded conversation, the St. David's doctor told Melissa her husband would not receive treatment because of his disability, despite her wishes. St. David's doctor: "So as of right now, his quality of life – he doesn't have much of one."

Melissa: "What do you mean? Because he's paralyzed with a brain injury he doesn't have quality of life?"

St. David's doctor: "Correct."

God has a plan for each person's life.

Lam. 4:18 They hunt our steps, that we cannot go in our streets: our end is near, our days are fulfilled; for our end is come.

Job 14:1 Man that is born of a woman is of few days, and full of trouble.

<u>2</u> He cometh forth like a flower, and is cut down: he fleeth also as a shadow, and continueth not. ...

5 Seeing his days are determined, the number of his months are with thee, thou hast appointed his bounds that he cannot pass;

Special consideration

Voluntary euthanasia or mercy killing is with the complete consent of the patient; non-voluntary euthanasia is killing a person who cannot give consent, and involuntary euthanasia is conducted against the consent of the patient. These can again be classified as active and passive euthanasia.

Active Euthanasia

Active euthanasia entails the active injection of a material that will cause cessation of functions that are required to continue the life. For example, injecting a large dose of morphine will cause cessation of respiration and injection of potassium chloride will cause arrhythmias and cardiac arrest. In most countries, this is considered criminal misconduct on the part of the doctor and generally brought to courts.

Passive Euthanasia

Passive euthanasia entails the withholding or non-performance of an action that would have saved that person. This can be elaborated by not allowing for the patient to be intubated, given oxygen, pushed in a drug that would resuscitate that person. These options can be opted by the patient or by consensus of the medical team. The patient can write up a living will or appoint a health care proxy asking for a "DNR" or "Do Not Revive" order. This is legally binding. Or else the healthcare team can discuss and get the consent of the legal guardian or the patient as to do nothing during the next emergency. This is accepted in most countries, but in some, the legality is blurry, at best.

Thus, active euthanasia is doing something to harm the patient, whereas passive euthanasia is not doing anything to save the patient.

If you are allowed to abort a fetus that has a severe genetic defect, microcephaly, spina bifida, or so on, then why aren't you able to euthanize that same fetus just after it's born?

Coyne makes the boringly predictable claim that since we euthanize our sick pets, we should also kill seriously ill and disabled babies. He then explains why he thinks the reasons we resist that meme are wrong, and indeed, irrational.

From his blog:

The reason we don't allow euthanasia of newborns is because humans are seen as special, and I think this comes from religion—in particular, the view that humans, unlike animals, are endowed with a soul.

It's the same mindset that, in many places, won't allow abortion of fetuses that have severe deformities. When religion vanishes, as it will, so will much of the opposition to both adult and newborn euthanasia. Coyne's odious advocacy is the logical outcome of accepting the following premises:

- That human life does not have unique value simply and merely because it is human, and;
 - That eliminating suffering is the overriding purpose of society–allowing the elimination of the sufferer.

Mt. 16:26 For what is a man profited, if he shall gain the whole world, and lose his own soul? or what shall a man give in exchange for his soul?
